Natalie Guinness, Head of Careers, talked to her presentation.

Head of Careers assists Y11-13 students transition from school into work or further education and training. Each Y13 student is seen once a year for a careers interview and all senior students are encouraged to make use of the careers staff.

The department offers a Dual Enrolment where students are enrolled in two educational institutions. This is available as part of the course selection process held in Term 2 each year.

Gateway Programme is funded by the Tertiary Education Commission and is designed to enable students to undertake workplace learning in many occupations at no cost to them. Year 11-13 students gain experience and get a minimum of 20 credits at NCEA level 2 or 3.

STAR (Secondary Tertiary Alignment Resource) provides opportunities for students to gain skills and experience in an industry through one off courses. Short courses are offered throughout the year and during school holidays.

Catherine acknowledged the hard and great work Natalie has done in her role and the steps she has put into the role.

1.6 Imogen Spray

Imogen presented her research to date which is now coming to an end. Her PhD research is looking at mental wellbeing and digital health across the country with her research based at AGHS this year. Imogen has spent 26 weeks in a range of classes and 11 students have been involved in her research observations. She has sat in classes building a rapport with students and conducting 1-1 interviews on students mental wellbeing and what a day at school looks like for them. The students came out with a range of comments with friendships being their main central focus, what makes a friendship feel good and how it impacts their sense of self, wellbeing and what they can achieve from it.

Imogen's research this year has been around data collection and at the end of this a detailed report will be written up which will be pertinent to the school. This report will not be a public report and the school will be kept confidential and not publicly shared.
